ARA U.S. Sales Circuit books resemble the APS books, with sixteen bound pages. Five formats are available (1, 4, 6, 9 or 12 stamp spaces per page.) Oversized one space per page books, $8\frac{1}{2} \times 11$ inches, for large taxpaids, revenues on documents and the like are also available. Only items will be accepted which can fit within the $4\frac{3}{4} \times 7\frac{1}{4}$ inch borders of the smaller books, or within the $8\frac{1}{2} \times 11$ inches books.

Books sell for 50¢ each, postpaid, regardless of format. Those submitting large material should request blank books, and affix glassine envelopes to the pages to contain their material. Members submitting books for circulation should use the categories shown on the circuit request form below as a guide for the mounting of material. Do not combine categories within a book.

This service is a benefit of ARA membership, and is available only to members of good standing.

A 10% sales commission will cover expenses of this service. Each member with U.S. collecting interests is encouraged to participate. Sales circuits are an easy way to add to your collection and to dispose of duplicates and unwanted material.
